## HOW TO APPLY

· Stir the product until totally smooth.

## SURFACE AND AMBIENT CONDITIONS

#### AMBIENT TEMPERATURE:

Do not paint at a temperature of below 7°C .

#### **RELATIVE HUMIDITY:**

Never apply with relative humidity exceeding 80%.

#### **AMBIENT CONDITIONS:**

It is not recommended to paint in rainy weather or at times of peak heat.

## POSSIBLE APPLICATION SYSTEMS

Use a brush or roller for normal application of Quitacqua. Apply thick films of the product using a brush, leaving it to act for an appropriate waiting time, taking into account that the longer it is left, the easier and deeper the stripping of the paint will be. The attacked and dissolved mass is then removed using a spatula. If it is a very hard or old paint it is best to score it, making criss-cross cuts, before application and repeat this operation several times because the product will slowly attack and dissolve the layer or layers of paint.

## SAFETY

Consult the current safety data sheet for safe handling (Section 8.2). Unsuitable for children. Keep out of the reach of children. Do not place painted surfaces into the mouth.
